Referendum

**Proposed
Constitutional Amendment**

To increase the maximum age at which a person may be elected or appointed judge, to eliminate the authority of the General Assembly to establish courts of conciliation, and to eliminate the authority of the Governor to appoint a Supreme Court Commission

Proposed by Joint Resolution of the General Assembly

To amend Section 6 of Article IV and to repeal Sections 19 and 22 of Article IV of the Constitution of the State of Ohio

A majority yes vote is required for the amendment to Section 6 and the repeal of Sections 19 and 22 to pass.

This proposed amendment would:

1. Increase the maximum age for assuming elected or appointed judicial office from seventy to seventy-five.
2. Eliminate the General Assembly's authority to establish courts of conciliation.
3. Eliminate the Governor's authority to appoint members to a Supreme Court Commission.

If approved, the amendment shall take effect immediately.

A "YES" vote means approval of the amendment to Section 6 and the repeal of Sections 19 and 22.

A "NO" vote means disapproval of the amendment to Section 6 and the repeal of Sections 19 and 22.

STATE ISSUE 3

**Proposed
Constitutional Amendment**

To preserve the freedom of Ohioans to choose their health care and health care coverage

**Proposed by Initiative Petition
To adopt Section 21 of Article I of the Constitution of the State of Ohio**

A majority yes vote is necessary for the amendment to pass.

The proposed amendment would provide that:

1. In Ohio, no law or rule shall compel, directly or indirectly, any person, employer, or health care provider to participate in a health care system.
2. In Ohio, no law or rule shall prohibit the purchase or sale of health care or health insurance.
3. In Ohio, no law or rule shall impose a penalty or fine for the sale or purchase of health care or health insurance.

The proposed amendment would not:

1. Affect laws or rules in effect as of March 19, 2010.
2. Affect which services a health care provider or hospital is required to perform or provide.
3. Affect terms and conditions of government employment.
4. Affect any laws calculated to deter fraud or punish wrongdoing in the health care industry.

If approved, the amendment will be effective thirty days after the election.

LAKE COUNTY COMMUNITY COLLEGE
(LAKELAND COMMUNITY COLLEGE)**

A majority affirmative vote is necessary for passage.

A renewal of a tax for the benefit of Lake County Community College District (Lakeland Community College) for the purpose of paying operating costs, purchasing furnishings, equipment and the construction and improvement of property at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to 15 cents for each one hundred dollars of valuation, for ten years, commencing in 2012, first due in calendar year 2013.

PROPOSED TAX LEVY (ADDITIONAL) KIRTLAND LOCAL SCHOOL DISTRICT

A majority affirmative vote is necessary for passage.

Shall a levy be imposed by the Kirtland Local School District for the purpose of **providing for the emergency requirements of the school district** in the sum of \$1,352,991 and a levy of taxes be made outside of the ten-mill limitation estimated by the county auditor to average 4 mills for each one dollar of valuation, which amounts to 40 cents for each one hundred dollars of valuation, for five years, commencing in 2011, first due in calendar year 2012?

PROPOSED TAX LEVY (RENEWAL) KIRTLAND PUBLIC LIBRARY

A majority affirmative vote is necessary for passage.

A renewal of a tax for the benefit of Kirtland Public Library for the purpose of current expenses at a rate not exceeding 1 mill for each one dollar of valuation, which amounts to 10 cents for each one hundred dollars of valuation, for four years, commencing in 2011, first due in calendar year 2012.

A renewal of a tax for the benefit of Willoughby City for the purpose of current expenses at a rate not exceeding 0.9 mill for each one dollar of valuation, which amounts to 9 cents for each one hundred dollars of valuation, for five years, commencing in 2011, first due in calendar year 2012.

PROPOSED TAX LEVY (RENEWAL) WILLOUGHBY CITY

A renewal of a tax for the benefit of Willoughby City for the purpose of general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges at a rate not exceeding 2 mills for each one dollar of valuation, which amounts to 20 cents for each one hundred dollars of valuation, for five years, commencing in 2011, first due in calendar year 2012.
