## ELECTION DAY WORKERS NEEDED

We appreciate your interest, as we always have a need for new poll workers. Below is an outline of information about being a poll worker in Lake County. Please fill out the bottom portion of this form and return it to us as soon as possible. Once we receive this form from you, we will be able to get you scheduled for a training session.

The pay for being a Poll worker (judge) is now **\$107.91** for Election Day. If you are a Presiding Judge you will receive **\$127.91** for Election Day. The Presiding Judge oversees the election process in your assigned precinct. The Presiding Judge is responsible for picking-up supplies the Saturday before the election and returning them on Election night to a designated site. Poll workers are to report to their assigned polling location at 6:00 a.m. and stay until after the polls close and all closing procedures are completed. The polls close at 7:30 p.m. Usually you should be done around 8:15 p.m. Poll workers are required to attend a training session prior to each election. You are paid **an additional \$20.00 for the training session**. The training lasts about 2 hours, and are scheduled during the month before the election. You will receive a notice to attend. Approximately 3 to 4 weeks after the election, poll workers will receive their checks, which is for Election Day and training.
